7	Primary Care Element	<p>Wirral Specialised Dental Service</p> <p><u>Site 1:</u> Victoria Central Dental Clinic Mill Lane, Wallasey, Wirral CH44 5UF</p> <p>Facilities are available for the provision of the full range of primary care in Paediatric Dentistry, including treatment under inhalation sedation and assessments for children requiring general anaesthesia. From July 2023, there will be 5 newly refurbished dental surgeries on site which are well equipped for the provision of dentistry. There is excellent support from a team of experienced dental nurses, and the opportunity to work alongside a dental therapist, allowing a team approach to care provision. This clinic is also well equipped for catering to the needs of all Paediatric patients including multiple bariatric dental chairs, hoist and wheelchair tipper. Domiciliary dental services are also provided when required.</p> <p>The appointee will be given to opportunity to actively engage with the clinical governance and quality improvement activity within the department.</p> <p><u>Site 2:</u> Arrowe Park Hospital Arrowe Park Rd, Upton, Wirral CH49 5PE</p> <p>There is access to theatre suites for the routine exodontia for children under day case general anaesthesia in the main hospital. This is a consultant lead service through LTH which is run within the hospitals in the Lancashire region and some sessions held in regional units.

Site 1:

UCLan Dental School, Preston

University of Central Lancashire issuing it's own BDS degrees for 4 year BDS graduate entry program and postgraduate degrees in periodontics, endodontics and implantology. Opportunities for undergraduate BDS and therapy teaching and some input to masters degrees. Clinics set up as one open bay and multiple closed rooms, access to CBCT and intraoral scanners as well as operating microscope and potentially inhalation sedation.

Site 2:

Skelmersdale Walk-In Centre, Skelmersdale

This small 2 surgery unit with inhalation sedation, microscope and OPT with bitewing facility is a legacy service from when the previous community dental services joint LTH. At this site level 2 and 3 care is provided to the West Lancashire residents for both Paediatric and Special Care Dentistry. Although contractually it operates as a hospital trust, the clinical work is very much what a CDS practitioner would encounter.

8	Description of the training post	<p>A Specialty Trainee ST1 appointment in Paediatric Dentistry is available for training to a Consultant Level.</p> <p>The objective of this training program is to produce a Consultant Paediatric Dentist who can provide local specialist services in a primary care and/or hospital setting.</p> <p><u>Main activities and responsibilities:</u></p> <ul style="list-style-type: none"> • To undertake specialist training in Paediatric Dentistry. • To undertake clinical procedures within the curriculum for Paediatric Dentistry. • To attend continuing education courses as appropriate. • To provide an exemplary ethical standard as a role model for students at all levels. • To take part in all aspects of clinical governance activities in the Directorate and participate in appraisal and postgraduate educational activities. <p>Clinical duties will include patient consultation clinics and operative sessions for provision of care under the direction of Consultants and Specialists in Paediatric Dentistry for patients who have been referred for secondary and tertiary care. However, this arrangement is indicative of the role and will be a result of balancing the needs of the Departments with those of the individual. For part-time or job-share appointments, timetables will need to be discussed individually. Timetables will be reviewed each year in line with the development needs of the individuals and opportunities for training within the wider North West region. Trainees may be expected to travel for block placements in hospitals and community dental clinics across the region.</p> <p><u>Entry Requirements</u></p> <p>The Specialty Trainee will be appointed by a committee comprising representatives of the Postgraduate Dean, Specialty Training Committee, the Teaching Hospitals, and National Panel of Specialists. Candidates must hold a registerable dental degree (B.D.S. or equivalent) and must be eligible for full registration with the GDC. Applicants will be expected to provide evidence of their competence to communicate in English.</p> <p><u>THE POST</u></p> <p>It is expected that the successful candidate will initially enter into a specialist (pre-CCST) training in Paediatric Dentistry and following passing of the Membership in Paediatric Dentistry, and completion of their 3 years (full-time) pre-CCST will enter into post-CCST training within the same unit. On completion of 2 yrs (full-time) post CCST training and successfully passing the ISFE, they will be eligible for a Consultant post in Paediatric Dentistry.
